**TENURE TRACK OR TENURED POSITION IN STATISTICS, with specialization in methods applied in empirical research of business and economics.**

The tenure track is open to talented individuals who have excellent potential for a scientific career. On the basis of their experience and competence, applicants will be placed at any of the three levels of the tenure track system: Assistant Professor (1st or 2nd term), Associate Professor or Full Professor. The candidates for the first-mentioned level are appointed for a fixed term, while the candidates for Associate Professor positions are appointed either permanently or for a fixed term. The full professor positions are permanent positions.

Throughout their careers, those under the academic tenure track system are expected to exercise and guide scientific research, to provide related higher academic education, to follow the advances of their field, to participate in service to the Aalto University community, and to take part in societal interaction and international collaboration in their field. Individuals placed on the Aalto University tenure track for professors have the possibility to advance in their career through regular performance assessments, which take into account their merits in all areas of their scope of duty.
