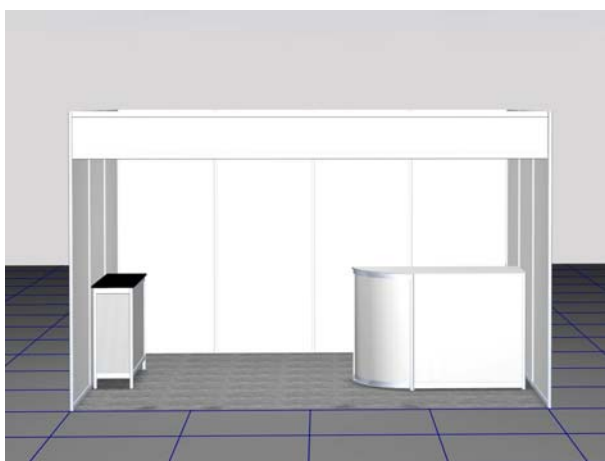
3. Exhibition

The exhibition of the EUROPACAT VIII congress will take place from 27 to 31 August 2007 at the Turku Fair and Congress Center. The location of the Exhibition is situated in the Main Aula of the Congress Center. The exhibition will be open during the congress hours (Monday to Friday).

4. Stand

The size of the standard exhibition stand is 12 m² (3 x 4 m). The basic setup includes:

- 1 Information desk (height 105 cm, top board size 150 x 50 cm)
- 1 Cabinet (height 90 cm, top board size 95 x 45 cm)
- 1 Light element (4 halogen spotlights)
- 1 Electrical wall socket (3 outlets, 230 V)
- 1 Carpet (3 x 4 m)

The organizer's liability insurance does not indemnify harm incurred to the exhibitor's own equipment and structures; therefore, the exhibitor must arrange for such insurance as required himself (risk, fire, theft, etc.).
